## 4.2 Changes in the Board of Trustees

It was noted that CS Victor Wakumile Ndururu had retired and CS Stephen Juma Saenyi appointed as a Trustee on 20<sup>th</sup> May 2022.

## **4.3 Governing Document**

It was reported that the Trust Deed and Rules had since been reviewed to meet the emerging issues and changing needs of members.

## 4.4 Objective of the Fund

The Benevolent Fund was established to assist distressed members and beneficiaries of the Fund. It was noted that all annual members are required to pay their annual membership subscriptions in full in a given year to be accorded any financial assistance.

## 4.5 Membership subscription fees

The Annual and Life membership subscriptions of the Fund was noted Kshs. 2,500 and Kshs. 30,000 respectively. All Annual members were required to pay their annual subscriptions in full in a given year to be eligible for any assistance from the Fund.

## 4.6 Financial Performance for the year 2022

The Fund balance was reported to have increased by 8.8% from Kes. 67,877,288 in 2021 to Kes. 73,857,084.00 in 2022. The growth was as a result of good performance of investments as well as growth in membership of the fund.

The portfolio was well diversified pursuant to the Fund's policies ranging from quoted shares, government securities, unit trusts and cash and cash equivalents with a view of protecting the members' funds from uncertainties of the economy.

## **4.7 Fund Membership**

For the year 2022, it was reported that the total Fund membership grew by 129 members or 8.6% from 1,503 members in the year 2021 to 1,632 members in the year 2022.

## 4.10 Strategic Plan

The Trustees had finalized the development of the Fund's Strategic Plan for the period 2023-2027, featuring the vision: "to be the premier welfare provider to members in times of distress", mission: "sustainable welfare for members", and Core Values being "Integrity, Empathy, Responsiveness, and Innovative". After a few highlights, the Chairman led members in launching the new strategic plan, with implementation scheduled to commence immediately.

The three key result areas (KRAs) were growth and development of membership; achievement of Fund sustainability; and enhancement of processes for excellent service delivery to stakeholders.

#### 4.11 Stakeholders Engagement

The Board of Trustees organized a successful member engagement webinar on 29<sup>th</sup> November 2022 to sensitize all members of the Institute, on the objectives of the Fund and developments realized thus far, the benefits of joining the Fund as well as rights and obligations of the members.

#### 4.12 Appointment of Corporate Secretary

The Board of Trustees had recruited CS Gloria Kikete, as the Corporate Secretary effective 18<sup>th</sup> August 2022. This was to replace the Chief Executive Officer (CEO) of the Institute who had been the Honorary Secretary of the Fund as per the Trust Deed. The Trustee's report was proposed by FCS Sam Ogutha and seconded by CS Malachi Adedeh.

# MIN.5/AGM/2023: AUDITED FINANCIAL STATEMENTS OF THE FUND FOR THE YEAR ENDED 31<sup>st</sup> DECEMBER 2022

The Fund's Audited Financial Statements for the year ended 31st December 2022 were presented by CPA Pius Kamau who thereafter invited the Independent Auditors, JAD Accountants, Certified Public Accountants (K) to present the Auditor's opinion.

The Engagement Partner, CPA Dennis Gicheru, read out the unqualified opinion signifying that the Fund's financial statements represented a True and Fair view of the financial position as at 31st December 2022, and in compliance with the accounting standards.

The Accounts were adopted with a proposal by CS Dr John Kennedy Omanga and seconded by FCS John Maonga.

#### MIN.6/AGM/2023: APPOINTMENT OF AUDITORS FOR THE FINANCIAL YEAR 2023

The External Auditor was excused from the meeting for discussions of this agenda. The Chairman notified members that the current Auditors, JAD Accountants, had expressed their willingness to continue in office.

It was resolved to re-appoint JAD Accountants, Certified Public Accountants as the Independent Auditors of the ICPSK Benevolent Fund for the year ending 31st December 2023 with a proposal by FCS Erastus Gitau and seconded by CS Jane Mwangi.

The Board of Trustees was authorized to fix the Auditors' remuneration.
